- 1. Chair Munro called the meeting to order at 1:30 p.m. and led introductions
- 2. Public comment: There were no public comments.
- 3. Recap Committee's Process for Selecting Remaining 10 Members Plus Three Alternates: Chair Munro recapped the committee's process to date.

After new scores were identified and discussed, Member Corcoran motioned to adopt the 10 new committee members with scores of 3 or higher. Member Torrey seconded the motion. The motion was unanimously approved among voters present.

• Alternates:

Member Corcoran motioned for the committee to review the 2s and 1s that are left on the list and vote for three alternates. During the next meeting, the entire committee will discuss the rules of how alternates should operate within the committee. Member Fisher seconded the motion. The motion was unanimously approved among voters present.

Member Waggoner motioned for the committee to vote between the candidates that have four votes and to select three of them to see the final top scorers. Member Fisher seconded the motion. The motion was unanimously approved among voters present.

After several rounds of voting to narrow down candidate choices, the top ranked alternates (based by votes received) were: 1st place – 4.5; 2nd place 4.2; and 3rd place 5.7. Member Waggoner motioned to accept the final alternate choices of 4.5, 4.2, and 5.7. Member Fisher seconded the motion. The motion was unanimously approved among voters present.
