IN THE MATTER OF APPOINTING
MEMBERS TO THE PUBLIC HEALTH
ADVISORY COMMITTEE (LM 3.538)

WHEREAS, the Public Health Advisory Committee has five vacancies as the result of completions-of-term (four) and a resignation; and

WHEREAS, Committee recruitment resulted in the receipt and consideration of three candidates for the non-Commissioner direct positions vacant positions, which candidates were considered in tandem with previously received, valid applications; and

WHEREAS, two members have sought and been approved for re-appointment and two others are hereby nominated; and

WHEREAS, the Board of Commissioners concurs with the appointment of the candidates for these vacant positions;

NOW, THEREFORE, the Board of County Commissioners **ORDERS** as follows:
